







MONTHLY SUMMARY

The portfolio recorded a positive return in February. The key contributors for the month were Aena, Norfolk Southern and Eversource Energy. Spanish airport operator Aena rose following strong January traffic and a better-than-expected 2023 result. US rail company Norfolk Southern jumped as activist investors launched a bid to replace the company's board and management. Eversource lifted as it announced the sale of two of its offshore wind projects after a long delay.

The largest detractors over the month were Xcel Energy, Severn Trent and United Utilities. Xcel fell after the company notified the market that a law firm was representing various property insurance interests to preserve a fallen utility pole that was situated within the vicinity of the major wildfire in Texas – with the implication that the law firm would sue for damages should Xcel's subsidiary SPS be found to have been negligent. UK water utilities Severn Trent and United Utilities fell on rising UK bond yields.
